

**REGULATION
ON FORM AND CONTENTS OF LABELS FOR THE IDENTIFICATION AND
REGISTRATION OF GAMING TABLES, AUTOMATIC EQUIPMENT AND PAY-
IN-PAY-OUT DESK IN BETTING SHOPS**

“Official Gazette RS” no. 152 dated 18 December 2020, 31 dated 11 April 2025

Article 1

This regulation closely defines the form and contents of labels for identification and registration of gaming tables, automatic equipment and pay-in-pay-out desks or betting terminals in betting shops.

Article 2

Label for identification and registration of gaming table must be displayed on the table and contain the following information:

- 1) numerical designation of the label;
- 2) name of the organiser of game of chance;
- 3) name of the laboratory authorised by the Minister of Finance;
- 4) unique serial number of the desk;
- 5) location/address of the casino building;
- 6) expiration date of the license;

Label for identification and registration of automatic equipment must be visible displayed on the automatic equipment and contain the following information:

- 1) numerical designation of the label;
- 2) name of the organiser of game of chance;
- 3) name of the laboratory authorised by the Minister of Finance;
- 4) unique serial number of the automatic equipment;
- 5) location/address of the building in which the automatic equipment is located;
- 6) expiration date of the approval.

Each separate, undetachable part of the multiplayer automatic equipment on which playing is possible is deemed a separate automatic equipment.

Label for identification and registration of automatic equipment must be visibly displayed on each separate, undetachable part of the multiplayer automatic equipment referred to in paragraph 3 above.

Label for identification and registration of pay-in-pay-out desk or betting terminal in betting shop must be visibly displayed on the equipment of pay-in-pay-out desk or the betting terminal and contain the following information:

- 1) numerical designation of the label;
- 2) name of the organiser of game of chance;

- 3) name of the laboratory authorised by the Minister of Finance;
- 4) location/address of the building in which pay-in-pay-out desk or betting terminal is located;
- 5) expiration date of the approval.

Article 3

Label for identification and registration of gaming desk, automatic equipment and pay-in-pay-out desk or betting terminal in betting shop is made from self-destructive white PVC material with an applied hologram 6 mm in width.

The label is self-adhesive, dimensions 80 mm x 60 mm.

Article 4

Label is produced and placed on a device by a laboratory authorised by Minister of Finance after checking the compliance of technical and functional characteristics, as well as in the event a automatic equipment is moved to a different location.

The device referred to in paragraph 1 above means gaming table, automatic equipment and equipment of pay-in-pay-out desk or betting terminal.

Label is valid until the expiration date of the license or the approval.

The laboratory has the exclusive authority for replacement or removal of the label.

The costs of labels purchasing are borne by the organiser.

The request for issuance of labels is submitted to a certified laboratory using a form - Request for Issuance of Device Identification and Registration Label, which is attached to this regulation and represents its integral part.

In case of automatic equipment that has been withdrawn from use and for which a new request for putting into use has been submitted, the certified laboratory referred to in paragraph 1 above prepares and places the same numerical designation of the label as the automatic equipment had before it was withdrawn from use.

Article 5

The Regulation on Form and Contents of Special Designation for Casino or Betting Shop or Pay-In-Pay-Out Desk in a Betting Shop ("Official Gazette RS", no. 129/04) ceases to be effective from the effective date of this Regulation.

Article 6

This Regulation enters into force on the eighth day from the day it is published in the "Official Gazette of the Republic of Serbia" and becomes effective on 11 July 2021.
