REGULATIONS

ON THE MANNER OF KEEPING RECORDS AND REPORTING ON PAYMENTS RECEIVED, PAYMENTS MADE, AS WELL AS REALIZED BETS, OR WINNINGS FOR EACH PAY-IN-PAY-OUT DESK IN A BETTING SHOP

"Official Gazette of the Republic of Serbia", no. 45 dated 28 May 2025.

Article 1

This regulation prescribes the manner of keeping records and reporting on received payments, made payments, as well as realized bets, i.e. winnings for each pay-in-pay-out desk in a betting shop.

Article 2

The organizer of special games of chance - betting (hereinafter: the organizer) keeps monthly records of payments received, payments made, as well as realized bets, i.e. winnings for each pay-in-pay-out desk in a betting shop, on the basis of which it determines the amount of the fee for organizing special games of chance - betting.

Article 3

The organizer submits data on received payments, made payments, realized bets, as well as realized winnings for each pay-in-pay-out desk in a betting shop to the Games of Chance Administration on MOP Form - Monthly turnover calculation for each pay-in-pay-out desk of the betting shop, which is printed with these regulations and forms an integral part thereof.

The MOP Form, which is filled out for each pay-in-pay-out desk of a betting shop where special games of chance are organized – betting, must contain the following data:

- 1) serial number;
- 2) numerical number of the pay-in-pay-out desk/ automatic equipment sticker;
- 3) amount of payments received from players;
- 4) amount of payments made to players;
- 5) amount of realized bets made by players;
- 6) amount of winnings realized by players;
- 7) amount of monthly fee for organizing games of chance betting;
- 8) total amount of payments received, payments made, realized bets, realized winnings and monthly fee for organizing;
- 9) payment fee;
- 10) electronic signature of the organizer's responsible person.

Article 4

The completed MOP Form is submitted no later than the fifth day of the month for the previous month, electronically by connecting to the web service of the Games of Chance Administration.

Article 5

On the date of entry into force of this regulation, the Regulation on the Manner of Keeping Mandatory Records and Reporting on Achieved Turnover per Pay-in-Pay-out Desk in Betting Shops ("Official Gazette of the Republic of Serbia", no. 152/20) shall cease to be valid.

Article 6

This regulation enters into force on the eighth day after its publication in the "Official Gazette of the Republic of Serbia".
