

REGULATIONS
ON THE MANNER OF KEEPING RECORDS AND REPORTING ON PAYMENTS
RECEIVED, PAYMENTS MADE, REALIZED BETS AND WINNINGS FOR SPECIAL
GAMES OF CHANCE THROUGH MEANS OF ELECTRONIC COMMUNICATION

"Official Gazette of the Republic of Serbia", no. 45 dated 28 May 2025.

Article 1

This regulation prescribes the manner of keeping records and reporting on received payments, made payments, as well as realized bets, i.e. winnings (hereinafter referred to as: bases) for special games of chance through means of electronic communication by the organizer of special games of chance through means of electronic communication (hereinafter referred to as: organizer).

Article 2

The organizer keeps monthly records regarding the organization of special games of chance through means of electronic communication, namely:

- 1) bases for special games of chance – betting;
- 2) bases for other special games of chance (hereinafter: other games);
- 3) bases for special games of chance that are organized by (re)broadcasting, i.e. delayed or direct transmission of live games that players play against the organizer (roulette, blackjack, baccarat, etc.);
- 4) payments received and payments made to the player's registration account;
- 5) transfer of funds from the promotional account to the player's registration account.

Article 3

The organizer enters the data on the basic information for each type of special game of chance through means of electronic communication - betting in the EMPC Form - Monthly Turnover Records for the Organization of Special Games of Chance Through Means of Electronic Communication - Betting, which is printed with these regulations and forms an integral part thereof.

The organizer submits the completed EMPC Form to the Games of Chance Administration by the fifth day of the month for the previous month, electronically by connecting to the web service of the Games of Chance Administration.

Article 4

The organizer enters the data on the basic fees for each type of game of chance through means of electronic communication for other games in the EMPOI Form - Monthly Turnover Records for the Organization of Special Games Of Chance Through Means of Electronic Communication for Other Games, which is printed with these regulations and forms an integral part thereof.

The organizer submits the completed EMPOI Form to the Games of Chance Administration by the fifth day of the month for the previous month, electronically by connecting to the web service of the Games of Chance Administration.

Article 5

The organizer enters the data on the basic information for each type of special game of chance through means of electronic communication that is organized by (re)broadcasting, i.e. delayed or direct transmission of live games that players play against the organizer, in Form EMPU/O - Monthly Turnover Records for the Organization of Special Games of Chance Through Means of Electronic Communication - Live/Delayed (Re)Broadcasting, which is printed with these regulations and forms an integral part thereof.

The organizer shall submit the completed EMPU/O Form to the Games of Chance Administration by the fifth day of the month for the previous month, electronically by connecting to the web service of the Games of Chance Administration.

Article 6

The organizer enters the data on payments received from and payments made to the player's registration account, data on payment channels (name of the payment institution, name of the legal entity or entrepreneur receiving top-ups to the player's registration account, numerical number of the pay-in-pay-out desk sticker, etc.) and the method of payments received (non-cash or cash), as well as the method of payments made (non-cash or cash), in Form EMU/I - Records of Monthly Amounts of Payments Received And Payments Made to the Registration Account for the Organization of Special Games of Chance Through Means of Electronic Communication, which is printed with these regulations and forms an integral part thereof.

The organizer shall submit the completed EMU/I Form to the Games of Chance Administration by the fifth day of the month for the previous month, electronically by connecting to the web service of the Games of Chance Administration.

Article 7

The organizer enters the data on the amount of funds transferred from the promotional account to the player's registration account in EMPR/ER Form - Record of Monthly Amounts of Funds from the Promotional Account to the Registration Account for the Organization of Special Games of Chance Through Means of Electronic Communication, which is printed with these regulations and forms an integral part thereof.

The organizer shall submit the completed EMPR/ER Form to the Games of Chance Administration by the fifth day of the month for the previous month, electronically by connecting to the web service of the Games of Chance Administration.

Article 8

On the date of entry into force of this regulation, the Regulation On the manner of Keeping Mandatory Records and Reporting on Achieved Turnover for Special Games of Chance Through Means of Electronic Communication ("Official Gazette of the Republic of Serbia", no. 152/20) shall cease to be valid.

Article 9

This regulation enters into force on the eighth day after its publication in the "Official Gazette of the Republic of Serbia".
