

REGULATIONS  
ON THE CONTENT OF RECORDS ON THE BASES FOR CALCULATING AND  
PAYING THE FEE FOR ORGANIZING SPECIAL GAMES OF CHANCE IN  
CASINOS AND ON THE CONTENT OF THE MONTHLY CALCULATION OF  
THE FEE FOR ORGANIZING SUCH GAMES

"Official Gazette of the Republic of Serbia", no. 45 dated 28 May 2025.

Article 1

This regulation prescribes the content of records on the bases for calculating and paying the fee for organizing special games of chance in casinos (hereinafter: the bases) and on the content of the monthly calculation of the fee for organizing such games.

Article 2

The bases are made up of:

- 1) in games where participants play against each other (poker, chemin de fer, etc.) - the value of the stakes received for participation in the game that the organizer retains from all participants in the game;
- 2) in games where participants play against each other in a tournament - the difference between the amount of stakes received for participation (registration fee) and the prize fund paid to participants, not less than 5% of the total stakes received for participation (registration fee);
- 3) in other games where participants play against the casino - the difference between the value of the stakes received for participation in the game and the winnings paid to players for all tables cumulatively.

The organizer keeps records of the bases for:

- 1) games that participants play against each other - separate records for each day separately, for each table and for each type of game, which is used to compile the monthly calculation form for the organization fee for each type of game, or table separately;
- 2) other games of chance in the casino - separate records for each day separately, for each type of game, which is used to compile the monthly calculation form for the organization fee;
- 3) tournaments - separate records of the amounts of stakes received for participation (registration fee) and the prize fund paid to tournament participants;
- 4) promotional tokens - separate records for promotional tokens awarded in accordance with the regulations governing the field of games of chance.

Article 3

The organizer enters the data on the bases, for each day, for each table and for each type of game of chance that participants play against each other in the casino, in DEO 1 Form - Daily records on bases for calculating and paying the fee for organizing special games of chance in the casino that participants play against each other, which is printed with these regulations and forms an integral part thereof.

#### Article 4

The organizer enters the data on the bases, for each day, for each type of game of chance in the casino that players play against the casino, in DEO 2 Form - Daily records on bases for calculating and paying the fee for organizing special games of chance in the casino that participants play against the casino, which is printed with these regulations and forms an integral part thereof.

#### Article 5

Based on the records referred to in Article 3 of these Regulations, the organizer enters the data on the calculated monthly base, per table, and for each type of game of chance that participants play against each other in the casino, in MON 1 Form - Monthly calculation of the fee for organizing special games of chance in the casino that participants play against each other, which is printed with these regulations and forms an integral part thereof.

The organizer submits the completed MON 1 Form to the Games of Chance Administration by the fifth day of the month for the previous month, electronically by connecting to the web service of the Games of Chance Administration.

#### Article 6

Based on the records from Article 4 of these Regulations, the organizer enters the data on the calculated monthly base, for all tables cumulatively and for each type of game of chance in the casino that players play against the casino, in MON 2 Form - Monthly calculation of the fee for organizing special games of chance in the casino that participants play against the casino, which is printed with these Regulations and forms an integral part thereof.

The organizer shall submit the completed MON 2 Form to the Games of Chance Administration by the fifth day of the month for the previous month, electronically by connecting to the web service of the Games of Chance Administration.

#### Article 7

The organizer enters the data on the tournament fee no later than the day of the tournament's completion in the MONT Form - Monthly calculation of the fee for organizing special games of chance in the casino that participants play against each other in the tournament, which is printed with these regulations and forms an integral part thereof.

The organizer shall submit the completed MONT Form to the Games of Chance Administration by the fifth day of the month for the previous month, electronically by connecting to the web service of the Games of Chance Administration.

#### Article 8

The organizer enters the data on promotional tokens at each table, for each type of game, at the end of each working day in the EPŽ Form - Records of promotional tokens, which is printed with these regulations and forms an integral part thereof.

#### Article 9

On the date of entry into force of this regulation, the Regulation on the Content of Records on the Bases for Calculating and Paying Fees for Organizing Special Games of Chance in Casinos and on the Content of the Monthly Calculation of Fees for Organizing Such Games ("Official Gazette of the Republic of Serbia", no. 152/20) shall cease to be valid.

#### Article 10

This regulation enters into force on the eighth day after its publication in the "Official Gazette of the Republic of Serbia".
