REGULATION

ON TECHNICAL AND FUNCTIONAL CHARACTERISTICS OF TABLES FOR GAMES OF CHANCE, AUTOMATIC EQUIPMENT FOR GAMES OF CHANCE AND BETTING EQUIPMENT, METHOD AND PROCEDURE FOR TESTING THE FULFILMENT OF THE NECESSARY CONDITIONS

"Official Gazette of the Republic of Serbia, No. 78 dated 12 September 2025.

Subject of regulation

Article 1.

This Regulaton prescribes in more detail the technical and functional characteristics of tables for games of chance, automatic equipment and betting equipment, the method and procedure for testing whether the necessary conditions have been met.

The provisions of this Regulaton relating to automatic equipment for games of chance shall apply accordingly to multi-automatic equipment.

Technical and functional characteristics of tables for games of chance

Article 2.

On tables for games of chance (hereinafter referred to as: tables) special games of chance are played, which players play against the machine or against each other, with balls, dice, cards or other props and which are played exclusively in the premises of the casino.

Only those games of chance that are described in the rules of the game, approved by the Games Of Chance Administration (hereinafter referred to as the Administration), can be played on the tables.

The functional characteristics of the tables imply the category and type of game of chance that is played on the tables.

The technical characteristics of the tables are the characteristics of the parts of the table that are built into the table and are an integral part of the game of chance.

The technical characteristics of the tables where players play against the casino, such as: the dimensions and leveling of the roulette wheel cylinders, the distance between the numbers on the roulette dial, the height and thickness of the borders between those numbers, the correct dimensions of the openings, the arrangement and balance of the weight of the rotating parts, the weight and shape of the ball must be such that the outcome of the games depends solely on chance.

Technical and functional characteristics of automatic equipment for games of chance

Article 3.

An automatic equipment for games of chance (hereinafter referred to as an automatic equipment) is an electromechanical, electronic and similar device that operates on the basis of a random number generator on which special games of chance are organized.

Each automatic equipment must have a marking (plaque) that clearly indicates: the name and address of the manufacturer, the type of cabinet, the date of manufacture (month and year) and the serial number.

The functional characteristics of the automatic equipment include the category and type of game of chance that is organized on the automatic equipment.

The technical characteristics of the automatic equipment are the characteristics of the parts of the automatic equipment that are built into the automatic equipment and represent an integral part of the game of chance, whereby the automatic equipment must be valid for playing and monitoring the game of chance (game visualization, monitor, terminal, buttons).

The automatic equipment must be constructed, i.e. set up, so that within the cycle of realization of all programmed combinations, it pays out to players at least 80% of the value of the payments in that cycle.

The automatic equipment that is put into use must have appropriate systems for recording the operation of the automatic equipment.

The result of the games of chance on the automatic equipment must depend exclusively on the randomness defined by the software or hardware random number generator.

The result of the software and hardware random number generators must be random, statistically independent and have the correct standard deviation and the correct probability distribution.

The result of the software random number generators must not be predictable without knowledge of the applied algorithm, implementation and initial values.

The automatic equipment must have a connector and, via electronic or electromechanical counters, which cannot be reset, record the amount, type and method of payments, payouts, stakes, winnings and jackpot winnings.

Access to the connector must be secured by a connection that, upon achieving access that can affect the information referred to in paragraph 10 of this Article, must be physically damaged (hereinafter referred to as a seal).

The seal shall be placed by a laboratory authorized by the Minister of Finance (hereinafter referred to as the laboratory), or by an authorized repair person, in accordance with the regulations that further prescribe the technical validity and conditions for the repair of tables, slot machines and slot machines.

The slot machine must be designed in such a way as to record information about the interruption or termination of the power supply and the time and number of opening or closing of the security door of the logic box in which the motherboard is placed, on which the operating system and games that can be played on the slot machine are stored.

Access to the logic box referred to in paragraph 13 of this Article must be secured by a (program) seal by the laboratory, or by an authorized repair person, in accordance with the regulations that further prescribe the technical correctness and conditions for the repair of tables, automatic equipment and betting equipment.

The automatic equipment must be designed in such a way that in the event of an interruption or loss of electrical power, the game can be continued without erasing or losing data from the automatic equipment's memory.

The automatic equipment must be designed in such a way that it can generate a digital signature that can be used to determine the identity, i.e. verify the integrity, authenticity and configuration of the automatic equipment's data when it is first put into use, before being put into use again in the event of a change in technical and functional characteristics or in the control process.

Technical and functional characteristics of betting equipment

Article 4.

The provisions of Article 3 of this Regulaton shall apply accordingly to betting equipment that have the characteristics of an automatic equipment, which contain motherboards on which games of chance are stored and are organized on automatic equipment that can be played on the betting equipment.

The provisions of Article 3, paragraphs 2-4, paragraphs 7-9 and paragraph 15 of these Regulations shall apply to gambling machines that allow players to play games of chance by betting on a computer-generated virtual event.

The provisions of these Regulations shall not apply to gambling machines that do not have the characteristics, or features, from paragraphs 1 and 2 of this Article and serve exclusively as a payment and payout point in a betting shop.

The provisions of these Regulations shall not apply to gambling machines from paragraphs 1-3. This article shall be subject to the provisions of the regulations prescribing the form and content of the label for marking and registering tables, vending machines and payment and payout points in a betting shop.

Testing of compliance of technical and functional characteristics of tables, automatic equipment and betting equipment carried out by the laboratory

Article 5.

Testing of compliance of the technical and functional characteristics of tables, automatic equipment and betting equipment, within the meaning of Articles 2-4 of this Regulaton, is carried out by the laboratory.

After completing the testing procedure referred to in paragraph 1 of this Article, the laboratory issues:

- 1) a certificate of compliance of the technical and functional characteristics of the model, i.e. version of the table, automatic equipment or betting equipment,
- 2) a certificate of compliance of the technical and functional characteristics of an individual table, automatic equipment or betting equipment,
- 3) a supplementary certificate of compliance of the technical and functional characteristics of an individual table, automatic equipment or betting equipment if there has been a change in the technical and/or functional characteristics.

The appropriate testing procedure referred to in paragraph 2 of this Article shall be carried out before the first use and before re-use, if there has been a change in the technical and/or functional characteristics of the table, automatic equipment or betting equipment, as well as at the request of the competent authority in the supervision procedure within the meaning of the Law on Games of Chance ("Official Gazette of the Republic of Serbia", No. 18/20 and 94/24 - hereinafter: the Law), and may also be carried out exceptionally, at the request of the person referred to in paragraphs 4 and 5 of this Article.

The request for the testing procedure referred to in paragraph 2, point 1) of this Article shall be submitted by the organizer, the manufacturer of the automatic equipment or betting equipment, or their authorized distributor for the territory of the Republic of Serbia, or the competent authority.

The request for the testing procedure referred to in paragraph 2, points 2) and 3) of this Article shall be submitted by the organizer or the competent authority.

The testing procedure referred to in paragraph 2, points 2) and 3) of this Article may be carried out exclusively for tables, automatic equipment and betting equipment for which the model or version of the certificate referred to in paragraph 2, item 1) of this Article has been previously issued.

Along with the request referred to in paragraph 4 of this Article, the laboratory shall be provided with technical documentation containing a description and markings of the model or version of the table, automatic equipment or betting equipment, the technical specification of the product being tested, a description of the conditions and rules of the games of chance that can be played.

Along with the request referred to in paragraph 4 of this Article, the laboratory shall be provided with a copy of the model or version of the table, automatic equipment or betting equipment that is the subject of the test.

Along with the request referred to in paragraph 5 of this Article, the laboratory shall be provided with a certificate of compliance with the technical and functional characteristics of the model, i.e. the version of the table, automatic equipment or betting equipment, a report on the

procedure carried out referred to in Article 6 of this Regulaton, and physical access to the specific product being tested shall be provided at the manufacturer's location where the product is put into use.

Article 6.

The testing procedure referred to in Article 5, paragraph 2, point 1) of this Regulaton shall be carried out at any appropriate location by applying technical testing standards, whereby the testing shall be carried out:

- 1) by analyzing the technical documentation of the model or version of the table, automatic equipment or betting equipment;
- 2) by checking the compliance of the model or version of the table, automatic equipment or betting equipment with the submitted technical documentation;
- 3) by physically inspecting the model or version of the table, automatic equipment or betting equipment;
- 4) by testing the operation of the hardware and software components of the model or version of the table, automatic equipment or betting equipment in order to verify the validity of the device and to verify compliance of the technical and functional characteristics prescribed by this Regulaton;
 - 5) by special testing of software and hardware random number generators;
- 6) by special testing of each game of chance stored in the motherboard of the automatic equipment or betting equipment and the operating system;
- 7) by special testing of each betting game on a computer-generated virtual event, especially in the case of betting equipment referred to in Article 4, paragraph 2 of this Regulaton;
- 8) by checking the validity of the playing and games of chance monitoring devices (monitor, terminal, buttons).

In the procedure referred to in paragraph 1 of this Article, the laboratory may use reports, analyses, certificates or other test results conducted by other reference domestic or foreign laboratories.

After the test referred to in paragraph 1 of this Article has been performed, the laboratory shall prepare a test report, which it shall keep for ten years and submit to the applicant, as well as to the Administration upon request.

If the laboratory, after the procedure referred to in paragraph 1 of this Article, determines that the model or version of the table, automatic equipment or betting equipment meets the requirements of technical and functional characteristics prescribed by this Regulaton, it shall issue a certificate referred to in Article 5, paragraph 2, point 1) of this Regulaton.

The certificate form referred to in Article 5, paragraph 2, point 1) of this Regulaton as Annex 1 is printed with this Regulaton and forms an integral part thereof.

Article 7.

The testing procedure referred to in Article 5, paragraph 2, points 2) and 3) of this Regulaton shall be carried out at the location of the organizer by applying technical testing standards, whereby the testing shall be carried out:

- 1) by analyzing the compliance of the model or version of the table, automatic equipment or betting equipment according to the report and certificate referred to in Article 6 of this Regulaton with the table, slot machine or slot machine;
- 2) by confirming the compliance of the digital signature of the software components of the model or version of the automatic equipment or betting equipment according to the report and certificate referred to in Article 6 of this Regulaton with the digital signature of the software

components of the automatic equipment or betting equipment;

- 3) by confirming, in the case of betting equipment referred to in Article 4, paragraph 2 of this Regulaton, that all betting games on a computer-generated virtual event for which playing on the betting equipment is enabled have the approval referred to in Article 109, paragraph 6 of the Law and the certificate referred to in Article 6 of this Regulaton;
- 4) by physically inspecting the model or version of the table, automatic equipment or betting equipment in order to verify the correctness of the device, the existence of adequate access to the connector and the logic box in which the motherboard on which the operating system and games are stored is placed in order to be eligible for a seal, within the meaning of Article 3, paragraphs 11 and 14 of this Regulaton;
- 5) by checking the validity of the playing and games of chance monitoring devices (monitor, terminal, buttons);
 - 6) by checking the correctness of the data transfer protocol to the server.

If the laboratory, after carrying out the procedure referred to in paragraph 1 of this Article, determines that the table, automatic equipment or betting equipment meets the requirements of technical and functional characteristics prescribed by this Regulaton, it shall issue a certificate, or a supplementary certificate, referred to in Article 5, paragraph 2, points 2) and 3) of this Regulaton.

The certificate form and the supplementary certificate form referred to in Article 5, paragraph 2, items 2) and 3) of this Regulaton, as Attachment 2 and Attachment 3, are printed with this Regulaton and form an integral part thereof.

The manufacturer shall submit to the Administration the certificate referred to in paragraph 4 of this Article before the first use of the table, automatic equipment or betting equipment, or the supplementary certificate referred to in paragraph 4 of this Article before the table, automatic equipment or betting equipment is put into use again.

Costs of testing compliance of technical and functional characteristics of tables, automatic equipment and betting equipment

Article 8.

The costs of testing the technical and functional characteristics of tables, automatic equipment and betting equipment are borne by the organizer, i.e. the applicant.

The laboratory publishes an updated price list that is publicly available on the laboratory's official website.

Final provisions

Article 9.

On the date of entry into force of this Regulaton, the Regulaton on the technical and functional characteristics of tables and automatic equipment for games of chance, the method and procedure for testing compliance with the necessary conditions ("Official Gazette of the Republic of Serbia", No. 152/20 and 22/21) shall cease to be valid.

Article 10.

This Regulaton shall enter into force on the eighth day after its publication in the "Official Gazette of the Republic of Serbia".
