REGULATIONS

ON DETAILED CONDITIONS, DOCUMENTATION, METHOD AND PROCEDURE FOR ORGANIZING THE JACKPOT, EXAMINATION OF COMPLIANCE WITH THE NECESSARY CONDITIONS FOR THE JACKPOT SYSTEM AND DATA EXCHANGE

"Official Gazette of the Republic of Serbia" No. 112 dated December 12, 2025

Article 1

This regulation prescribes more detailed conditions, documentation, method and procedure for organizing jackpots, examining whether the necessary conditions for jackpot systems are met, and data exchange with the Games of Chance Administration (hereinafter: the Administration).

Article 2

The Administration grants consent to organize a jackpot (hereinafter: consent) to the organizer of special games of chance (hereinafter: organizer) based on the organizer's request to organize a jackpot, for a period of maximum one calendar year - from January 1 to December 31 of the same calendar year, both dates included.

Article 3

During the duration of the consent, the maximum amount of the total jackpot paid out cannot exceed:

- 1) for special games of chance betting 20% of the base amount made up of the difference between the total realized value of bets and the total realized value of player winnings in connection with special games of chance betting with the organizer, in the previous calendar year, or in the current calendar year with the organizer who acquired the right to organize games of chance betting in the current calendar year;
- 2) for special games of chance on automatic equipment 20% of the base amount made up of the difference between the total realized value of bets and the total realized value of player winnings in connection with special games of chance on automatic equipment with the organizer, in the previous calendar year, or in the current calendar year with the organizer who acquired the right to organize games of chance on automatic equipment in the current calendar year;
- 3) for special games of chance through electronic means of communication -20% on the base amount of the difference between the total realized value of bets and the total realized value of player winnings in connection with special games of chance through electronic means of communication with the organizer, in the previous calendar year, or in the current calendar year with the organizer who acquired the right to organize games of chance through electronic means of communication in the current calendar year.

The restrictions from paragraph 1 of this Article do not apply to the paid out jackpot that does not reduce the base amount for calculating the fee for organizing special games of chance and when the economic burden of the paid out jackpot is borne by a third party.

Article 4

The Administration shall not grant consent if the organizer has exceeded the maximum amount of paid out jackpots in the previous or current calendar year from Article 3, paragraph 1 of these Regulations.

Consent shall not be required for the use of the term "jackpot" if both conditions are met simultaneously:

1) the term "jackpot" is used exclusively to designate a winning that is achieved in the cycle of realization of all combinations of winnings that can be programmed; and

2) no part of the pay-ins is set aside for the pay-out of that winning.

Article 5

The request for organizing a jackpot shall be submitted for each upcoming calendar year, no later than the end of the current calendar year.

By way of exception to paragraph 1 of this Article, an organizer who has acquired the right to organize games of chance in the current calendar year may, within 90 days from the date of obtaining a permit from the Government, or approval from the Administration, submit a request for organizing a jackpot in the current calendar year.

The organizer shall submit the request referred to in paragraphs 1 and 2 of this Article to the Administration no later than 30 days before the start of organizing the jackpot.

The request for organizing the jackpot, which contains information on the name and registered office of the organizer, shall be accompanied by the following documentation:

- 1) a certificate of compliance with the requirements of the jackpot system;
- 2) decision of the competent authority of the organizer on organizing the jackpot;
- 3) jackpot rules.

An organizer using a third-party jackpot system where the paid jackpot does not reduce the basis for calculating the fee for organizing special games of chance and when the economic burden of the paid jackpot is borne by a third party, shall not submit a request for organizing such a jackpot, but shall without delay submit to the Administration:

- 1) a decision of the organizer's competent authority on participation in the jackpot organized by a third party;
- 2) evidence of the legal basis that the paid jackpot does not reduce the base amount for calculating the fee for organizing special games of chance and that the economic burden of the paid jackpot is borne by a third party.

The documents referred to in paragraphs 4 and 5 of this Article shall be submitted in the original or a certified copy.

If, during the year in which the organizer organizes the jackpot, any data related to paragraph 4, item 1) of this article changes, the organizer is obliged to submit a supplementary certificate of compliance with the requirements of the jackpot system and obtain additional consent from the Administration before continuing to organize that jackpot.

Article 6

The jackpot is organized exclusively through the jackpot system.

The organizer may organize exclusively the following types of jackpots:

- 1) progressive jackpot (hereinafter referred to as: progressive jackpot);
- 2) fixed-amount jackpot (hereinafter referred to as: fixed-amount jackpot).

A progressive jackpot is a type of jackpot that is created by accumulating a defined portion of the participants' stakes, with the jackpot winnings being awarded using a random number generator (English: RNG – Random Number Generator).

The progressive jackpot configuration can be based on:

- 1) a model in which the award is made after the accumulation of bets reaches a predefined jackpot limit, or
- 2) a model in which the maximum jackpot amount is not predefined, but the probability of the progressive jackpot award increases in proportion to the growth of the accumulated stake amount.

The progressive jackpot system must allow for parameter configuration that includes:

- 1) the minimum progressive jackpot amount,
- 2) the maximum jackpot amount (if applicable),
- 3) the initial jackpot amount,
- 4) the percentage of stakes that is added to the amount from point 3) of this paragraph,
- 5) parameters that affect the amount or probability of awarding the progressive jackpot.

A fixed-amount jackpot has a fixed jackpot value, while the chance of winning the jackpot can be variable.

A fixed-amount jackpot must be configured in a way that allows for the selection of the jackpot amount, the chance of winning the jackpot amount, the time of the jackpot, an optional increase in the chance in relation to time, the amount or number of bets, as well as the elements that participate in determining the jackpot amount.

The selection of the winner of a fixed-amount jackpot is done randomly, using a random number generator (English: RNG – Random Number Generator).

Article 7

The organizer's jackpot system must meet the following requirements for organizing a jackpot:

- 1) to ensure constant security of data processing and storage, i.e. to:
 - (1) have an encryption mechanism for data transmission, processing and storage,
 - (2) contain a protocol for data storage and backup, as well as protection against data loss and unauthorized access to the jackpot system;
- 2) that the random actions performed through the jackpot system (jackpot award, determination of the amount in the case of a progressive jackpot, etc.) must be determined by a random number generator (RNG), i.e. that:
 - (1) all random actions performed through the jackpot system are based exclusively on the random number generator (RNG),
 - (2) the random number generator (RNG) used in the jackpot system produces results within acceptable statistical deviations and meets the randomness criteria,
 - (3) the source of entropy and the method of generating initial values (seed values) ensure a sufficient level of entropy and unpredictability of the initial values,
 - (4) there is no possibility of manual intervention in the results of the random number generator (RNGs);
- 3) that the amount and probability of the jackpot pay-out are programmed in such a way that the jackpot pay-out can be reasonably expected within one year from the date of activation of the jackpot system, i.e. that:
 - (1) the algorithm configuration and the logic for calculating the probability of payout ensure that the jackpot payout can be statistically reasonably expected within one year from the date of activation of the jackpot system,
 - (2) the jackpot system meets all conditions regarding the stability of the algorithm and the uniformity of the probability of winning in accordance with applicable technical standards;
 - 4) that the random number generator that is part of the jackpot system must comply with the standards of the authorized laboratory, i.e. that:
 - (1) the random number generator (RNG) that is part of the jackpot system meets the standards prescribed by the internal documents of the authorized laboratory,
 - (2) the software module of the random number generator (RNG) has a valid hash verification, which confirms the integrity and immutability of the executable code in relation to the approved reference sample;
- 5) that access rights to the hardware and software of the jackpot system must be organized and secured in a manner that prevents access to data that can be reasonably considered risky in terms of the possibility of manipulating the jackpot allocation, i.e. that:
 - (1) it contains logical and physical segmentation in order to prevent unauthorized access to the components of the jackpot system that contain confidential data and data that could enable manipulation of the jackpot allocation,
 - (2) it contains the possibility of controlling access, limiting administrative privileges and keeping records of all accesses and changes made to the jackpot system,
 - (3) it ensures the immediate detection and blocking of any attempt at

unauthorized intervention or change of parameters that could affect the jackpot allocation;

- 6) that there is no possibility of organizing other types of jackpots than those prescribed by these regulations, i.e. that:
 - (1) it exclusively supports the organization of progressive jackpots and fixed-amount jackpots,
 - (2) it contains a system configuration that prevents the possibility of organizing other types of jackpots from being activated later;
- 7) that there is a possibility of establishing a permanent connection between the jackpot system and the organizer's information and communication system, i.e. that:
 - (1) it establishes a stable, continuous and secure connection with the organizer's information and communication system, in accordance with technical conditions and standards,
 - (2) it enables reliable data transfer without delay, with the application of appropriate encryption mechanisms and information integrity protection,
 - (3) it ensures complete synchronization and recording of all relevant events in real time, as well as ensures the accuracy and consistency of data between all components of the jackpot system;
- 8) that there is a possibility of exchanging information with the Administration's information system in real time, i.e. that:
 - (1) it has the technical capabilities for exchanging data with the Administration's information system in real time, compatibility of data formats and communication protocols with the formats necessary for data exchange,
 - (2) it enables logical synchronization with the Administration's information system, including identification and correction of possible data discrepancies during and after transmission.

The Certificate of Compliance with the Conditions of the Jackpot System referred to in Article 5, paragraph 4, item 1) of these Regulations, as well as the supplementary certificate referred to in Article 5, paragraph 7 of these Regulations, shall be issued to the organizer by a laboratory authorized by the Minister of Finance upon determination of compliance with the conditions referred to in paragraph 1 of this Article.

The form of the Certificate of Compliance with the Conditions of the Jackpot System (Annex 1) and the form of the Supplementary Certificate of Compliance with the Conditions of the Jackpot System (Annex 2) are printed with these Regulations and form an integral part thereof.

Article 8

This regulation shall enter into force on the eighth day after its publication in the "Official Gazette of the Republic of Serbia".
