На основу члана 136. Закона о општем управном поступку ("Сл. гласник РС", бр. 18/2016, 95/2018 - аутентично тумачење и 2/2023 - одлука УС) и члана 122. став 5. Закона о играма на срећу („Сл. гласник РС“ бр. 18/20 и 94/2024) у поступку канцеларијског инспекцијског надзора провере и утврђивања законитости и правилности примене Закона о играма на срећу („Сл. гласник РС“ бр. 18/20 и 94/2024), инспектор Управе за игре на срећу доноси:

РЕШЕЊЕ

I Забрањује се приређивање игара на срећу у Републици Србији путем веб презентација правном лицу из иностранства **Neon Games S.R.L.** регистарски број **3-102-91221** из **Costa Rica**, са седиштем на адреси **Province 01 San Jose, Canton 01 San Jose, Cathedrale district, Tenth avenue, Thirty-three and Thirty-five streets, Office three three five (the “Company)** преко IP адреса наведених у прилогу решења.

II Жалба не одлаже извршење решења.

Образложење

Инспектор Министарства финансија - Управе за игре на срећу, Богосав Митровић, број службене легитимације бр. 002, у спроведеном поступку канцеларијског инспекцијског надзора приређивања игара на срећу од стране лица из иностранства које приређује игре на срећу преко средстава електронске комуникације на територији Републике Србије, за које приређивање лице из иностранства нема одобрење које даје Управа за игре на срећу у складу са Законом о играма на срећу („Сл. гласник РС“ бр. 18/20 и 94/2024, у даљем тексту: Закон), утврдио је да приређивач игара на срећу **Neon Games S.R.L.** регистарски број **3-102-91221** из **Costa Rica**, са седиштем на адреси **Province 01 San Jose, Canton 01 San Jose, Cathedrale district, Tenth avenue, Thirty-three and Thirty-five streets, Office three three five (the “Company)** не поседује одобрење за приређивање посебних игара на срећу преко средстава електронске комуникације које даје Министарство финансија - Управа за игре на срећу.

Списак свих приређивача који поседују одобрење за приређивање игара на срећу Министарства финансија, Управе за игре на срећу, налази се на сајту Управе за игре на срећу <https://uis.gov.rs/rsc/spisaknaziv>.

Одредбама члана 9. став 1. тачка 1) Закона прописано је да је приређивач игара на срећу правно лице или предузетник који у складу са овим Законом, на основу дозволе Владе Републике Србије, односно одобрења или сагласности Управе за игре на срећу (у даљем тексту: Управа) има право да приређује игре на срећу.

Према одредбама члана 20. Закона, право на приређивање посебних игара на срећу преко средстава електронске комуникације преноси се одобрењем које даје Управа, у складу са Законом, односно да право на приређивање класичних игара на срећу преко средстава електронске комуникације има једино Државна лутрија Србије и то без посебног одобрења.

У складу са одредбама члана 92. став 1. Закона, право на приређивање игара на срећу преко средстава електронске комуникације имају Државна лутрија Србије и приређивачи чија је регистрована претежна делатност коцкање и клађење, којима је Управа одобрењем пренела право на приређивање посебних игара на срећу преко средстава електронске комуникације. Одобрење из става 1. овог члана даје се решењем Управе.

Сходно члану 122. ст. 5. и 6. Закона, када у вршењу инспекцијског надзора инспектор Управе открије да лице из иностранства приређује игре на срећу преко средстава електронске комуникације, а за које приређивање нема одобрење Управе издато у складу са Законом, донеће решење којим забрањује приређивање игара на срећу и исто ће доставити и надлежном органу који ће обезбедити онемогућавање приступа његовој интернет адреси блокадом IP адресе (енг: Internet Protocol address) од стране оператора електронских комуникација, односно јавних комуникационих мрежа и трансакције плаћања од стране банака и других пружаоца платних услуга у Републици Србији.

Применом одредаба члана 122. ст. 5. и 6. а имајући у виду да је у поступку инспекцијског надзора утврђено да правно лице **Neon Games S.R.L.** регистарски број **3-102-91221** из **Costa Rica**, са седиштем на адреси **Province 01 San Jose, Canton 01 San Jose, Cathedrale district, Tenth avenue, Thirty-three and Thirty-five streets, Office three three five (the "Company)**, приређује игре на срећу преко средстава електронске комуникације на територији Републике Србије, за које приређивање нема одобрење које даје Управа у складу са Законом, одлучено је као у диспозитиву овог решења.

Ово решење почиње да производи правна дејства од када је странка о њему обавештена, сходно члану 17. Закона о општем управном поступку ("Сл. гласник РС", бр. 18/2016, 95/2018 - аутентично тумачење и 2/2023 - одлука УС).
