

In accordance with Article 55, paragraph 5 of the Law on Games of Chance (“Official Gazette of the Republic of Serbia”, No. 18/20),

the minister of finance issues the following

REGULATION
ON THE CONTENT OF THE RECORDS ON WHICH THE CALCULATION AND
PAYMENT OF THE FEE FOR ORGANISING SPECIAL GAMES OF CHANCE IN
CASINOS IS BASED AND ON THE CONTENT OF THE MONTHLY CALCULATION OF
THE FEE FOR ORGANISING SPECIAL GAMES OF CHANCE IN CASINOS

(Official Gazette of the Republic of Serbia, No. 152/20)

The basic text comes into force from 26/12/2020, the application of this regulation comes into force from 11/07/2021.

Article 1

This regulation prescribes the content of the records which form the basis for calculating and paying the fee for organising special games of chance in casinos and the content of the monthly calculation of the fee for organising said games.

Article 2

The organiser is obliged to keep records that form the basis for calculating and paying the fee for organising special games of chance in casinos (hereinafter: the “**basis**”) for each day separately, for each table and for each type of the game, and which are used to compile the monthly form for calculating the organisation fee for each type of game, i.e. each table separately, as well as keeping records on promotional chips in accordance with the regulations governing the field of games of chance.

Article 3

The organiser is obliged to enter data on payments, withdrawals and the basis for each day, at each table and for each type of game of chance in a casino where players play against the casino in a DRB form – daily record for the basis of the calculation and payment of the organisation fee for special games of chance in a casino – which is printed together with this regulation and forms an integral part thereof.

Article 4

The organiser is obliged to enter data on payments, withdrawals and the basis for each day, at each table and for each type of game of chance in which participants play against each other in a casino in a DRB 1 form – daily record for the basis for the calculation and payment of the organisation fee for special games of chance in a casino in which participants play against one another – which is printed together with this regulation and forms an integral part thereof.

Article 5

Based on the records referred to in Article 3 of this regulation, the organiser is obliged to enter data on payments and withdrawals and the calculated monthly basis for each table and for each type of game of chance in a casino in which players play against the casino in an MCF form – monthly calculation of the fee for organising special games of chance in a casino – which is printed together with this regulation and forms an integral part thereof.

Article 6

Based on the records referred to in Article 4 of this regulation, the organiser is obliged to enter data on payments and withdrawals and the calculated monthly basis at each table and for each type of game of chance in which participants play against each other in a casino in an MCF 1 form – monthly calculation of the fee for organising special games of chance in a casino in which participants play against one another – which is printed together with this regulation and forms an integral part thereof.

Article 7

The organiser is obliged to enter the data on promotional chips for each table and for each type of game at the end of each working day in an RPC form – records on promotional chips – which is printed together with this regulation and forms an integral part thereof.

Article 8

(1) If the performance of state administration activities in the field of games of chance is performed by applying information and communication technologies, the organiser is obliged to exchange electronically with the software solution of the Games of Chance Administration (hereinafter: the “**Administration**”) all data related to payments and withdrawals on a daily basis.

(2) The organiser must submit the completed forms referred to in Articles 5 and 6 of this regulation no later than the fifth day of the month for the previous month electronically by connecting to the web service of the Administration.

(3) The organiser is obliged to submit the completed forms referred to in Articles 5 and 6 of this regulation electronically to the e-mail address of the Administration until the establishment of the technical conditions for electronic connection to the web service of the Administration.

Article 9

On the day the application of this regulation begins, the regulation on the content of records on which the fee for organising special games of chance in casinos is based and on the content of the monthly calculation of the fee for organising these games (“Official Gazette of the Republic of Serbia”, No. 35/06 and 44/18 - other law) shall cease to be valid.

Article 10

This regulation shall enter into force on the eighth day from the date of its publication in the “Official Gazette of the Republic of Serbia” and shall apply from 11 July 2021.
