In accordance with Article 102, paragraph 6 of the Law on Games of Chance ("Official Gazette of the Republic of Serbia", No. 18/20),

the minister of finance issues the following

#### REGULATION

#### ON THE MANNER OF KEEPING MANDATORY RECORDS AND REPORTING ON ACHIEVED TURNOVER FOR SPECIAL GAMES OF CHANCE THROUGH MEANS OF ELECTRONIC COMMUNICATION

#### (Official Gazette of the Republic of Serbia, No. 152/20)

## The basic text comes into force from 26/12/2020, the application of the regulation comes into force from 26/12/2020.

#### Article 1

This regulation prescribes the manner of keeping mandatory records and reporting on the realised turnover for special games of chance through means of electronic communication by the organisers of special games of chance through means of electronic communication (hereinafter: the "organiser").

#### Article 2

The organiser is obliged to keep records of the turnover for the calculation and payment of fees for organising special games of chance through means of electronic communication, for each day separately, which is used for the preparation of the monthly calculation of fees for each type of game, based on which it determines the amount of the fee for organising special games of chance through means of electronic communication.

#### Article 3

The organiser is obliged to provide data on the registration number of the transaction, PIN of the player (or passport number if the player is a foreign national), the amount of payments made by the players, the amount of payments received by the player and the basis, for each day, for each type of betting game of chance through means of electronic communication in an RDT form – record of daily turnover for organising special betting games of chance through means of electronic communication – which is printed together with this regulation and is an integral part thereof.

#### Article 4

The organiser is obliged to provide data on the registration number of the transaction, PIN of the player (or passport number if the player is a foreign national), the amount of payments made by the players, the amount of payments received by the player, the amount of payments made to the player and the basis, for each day, for each type of other game of chance through means of electronic communication in an RDTO form – record of daily turnover for organising other special games of chance through means of electronic communication – which is printed together with this regulation and is an integral part thereof.

#### Article 5

The organiser is obliged to provide data on the amount of payments made by the players, the amount of payments received by the player and the basis for each type of betting games of chance through means of electronic communication in an RMT form – record of monthly turnover for organising special betting games of chance through means of electronic communication – which is printed together with this regulation and is an integral part thereof.

#### Article 6

The organiser is obliged to enter data on the amount of payments made by the players, the amount of payments received by the player and the basis for each type of other games of chance through means of electronic communication in an RMTO form – record of monthly turnover for organising other special games of chance through means of electronic communication – which is printed together with this regulation and is an integral part thereof.

#### Article 7

(1) The organiser submits the completed RMT and RMTO forms from Articles 5 and 6 of this regulation to the Games of Chance Administration by the fifth day of the month for the previous month, electronically by connecting to the web service of the Games of Chance Administration.

(2) The organiser is obliged to submit the completed forms from Articles 5 and 6 of this regulation electronically to the e-mail address of the Administration until the establishment of the technical conditions for electronic connection to the web service of the Administration.

#### Article 8

This regulation shall enter into force on the eighth day from the date of its publication in the "Official Gazette of the Republic of Serbia".
